


1 INTRODUCTION

This document describes the terms of reference and membership of the Tissue Governance committee acting on behalf of the Lothian NRS BioResource. This committee will act as the Access Committee and make decisions on whether applications are approved or not and the terms Tissue Governance Committee and Access Committee will be considered to be synonymous.

2 OVERVIEW

- 2.1 All requests to the BioResource are reviewed by the Tissue Governance Committee who will scrutinise each request for the appropriateness of the science and ethics. The exception to this will be where a request has been previously peer reviewed, in which case, if there is an abundance of tissue available, it may be reviewed by the Tissue Governance management alone.
- 2.2 The Lothian NRS BioResource has an open access policy and all bona fide requests from legitimate researchers including commercial entities will be considered. (See Tissue and Data Access Policy - QP-TGU-A-TDACPOL)
- 2.3 If tissue has been collected for a specific study, the research group who collected it will be respected as the first end user, and during the period of study, access will be restricted.
- 2.4 The Tissue Governance committee is responsible to the Executive Medical Director for NHS Lothian.
- 2.5 The Tissue Governance Committee mainly operates electronically, and all requests are sent round by email. Applications may also be discussed at face-to-face meetings, particularly if there are any issues to be resolved.

4 PROCEDURE

- 4.1 All requests for tissue and data should be submitted to the Tissue Governance Manager or Tissue Governance Officer on form QP-TGU-A-ACCESSR.
- 4.2 The Tissue Governance Manager or Tissue Governance Officer will conduct an initial review of the application and refer back to the applicant with any queries, issues or amendments, within 10 working days were possible.

- 4.3 Once all parties are agreed that the application is ready for submission, the request will be sent to the Tissue Governance Committee for review by means of email by the Tissue Governance Manager or Tissue Governance Biomedical Science Officer.
- 4.4 A response from committee members should be made in a timely fashion, with a target of 10 working days. In the event of a researcher being asked to supply additional information, the clock will be stopped.
- 4.5 The review process must respect the conditions of donor consent where relevant and all use of tissue and data must come under the terms of the RTB ethical approval granted by the East of Scotland REC, reference number 20/ES/00061 (previously 15/ES/0094).
- 4.6 The review process should assess the quality of the science, protocol and monitor any risk.
- 4.7 Restriction of access must be handled in a transparent manner and any refusal to supply tissue samples must be accompanied by an explanation eg in the event of rare or precious samples where the fulfilment of the request would deplete the resource.
- 4.8 In the case of requests for archival pathology samples there must be sufficient tissue remaining in the block to maintain the patient record.
- 4.9 Where an applicant requesting tissue is also a member of the Tissue Governance Committee, they will be deemed to have a conflict of interest and will be excluded from the review process for that request.
